UPS Ground Domestic and UPS Ground Saver® (Formerly Known as UPS SurePost®) Fuel Surcharge

UPS uses an index-based surcharge that is adjusted weekly. Changes to the surcharge will be effective on Monday of each week. The surcharge will be based on the National U.S. Average On-Highway Diesel Fuel Price as most recently released by the U.S. Energy Information Administration (EIA) rounded to the nearest cent. For example, the surcharge for the week of May 12, 2025 is based on the National U.S. Average On-Highway Diesel Fuel Price released by the EIA the week of May 5, 2025.

UPS Domestic Air Fuel Surcharge

UPS uses an index-based surcharge that is adjusted weekly. Changes to the surcharge will be effective on Monday of each week. The surcharge will be based on U.S. Gulf Coast (USGC) price for kerosene-type jet fuel as most recently released by the U.S. Energy Information Administration (EIA) rounded to the nearest cent. For example, the surcharge for the week of May 12, 2025 is based on the U.S. Gulf Coast (USGC) price for kerosene-type jet fuel released by the EIA the week of May 5, 2025.

If the diesel fuel pricing information released by the EIA is delayed, UPS may use released diesel fuel pricing information from an earlier week.

The U.S. Ground Domestic and UPS Ground Saver® Fuel Surcharge will apply to charges for the following services:

UPS Ground®, UPS® Ground with Freight Pricing, UPS Hundredweight Ground Service, UPS Ground Saver® and UPS® Basic.

The U.S. Ground Domestic and UPS Ground Saver Fuel Surcharge does not apply to UPS Ground packages originating in the 48 contiguous United States when subject to Retail rates.

The Domestic Air Fuel Surcharge will apply to charges for the following services:

UPS Next Day Air® Early, UPS Next Day Air®, UPS Next Day Air Saver®, UPS 2nd Day Air A.M.®, UPS 2nd Day Air®, UPS 3 Day Select®, and UPS Hundredweight Air services.

Fuel surcharges apply to all domestic and international transportation charges and certain other accessorial charges, value added charges, surcharges and other charges.
