



Surge Emergency Fee and Demand Surcharge

4 October 2026 – 6 February 2027

To maintain service reliability and secure the additional resources required to support our customers, we are implementing the **Surge Emergency Fee** and **Demand Surcharge**.

Surge Emergency Fee (International Air)

- A Surge Emergency Fee will apply to international air shipments on selected lanes and services.
- International services include Express, Express Saver, Express Plus, Expedited and Worldwide Express Freight.
- The Surge Emergency Fees are subject to a fuel surcharge and will apply based on the billable weight of the shipment for international shipments.

Rates per kilogram for international air shipments

From 4 October 2026, a Surge Emergency Fee will apply to international air shipments on the lanes listed in the table below.
