



Surge Emergency Fee & Demand Surcharge

6 September 2026

In response to market conditions, the following updates will take effect as of 6 September 2026, and will remain in place until further notice:

Surge Emergency Fee (Domestic)

- A Surge Emergency Fee¹ of **€0.55 per package** will be applied to domestic shipments (domestic Standard, Express, Express Saver, Express Plus), delivered to residential and commercial addresses.
- This fee is only applicable to customers billed in Italy.
- This fee is subject to fuel surcharge.
- Please note that Surge Emergency Fee is subject to change. Shippers should regularly check the UPS.com Shipping Zones and Rates page for updates prior to tendering shipments.

Surge Emergency Fee (International)

- A Surge Emergency Fee will apply to international air shipments on selected lanes and services.
- International Air services include Express, Express Saver, Express Plus, Expedited, and Worldwide Express Freight.
- This fee is only applicable to customers billed in Italy.
- This fee is subject to fuel surcharge and will apply based on the billable weight of the shipment for international shipments.
- Please note that Surge Emergency Fee is subject to change. Shippers should regularly check the [UPS.com](https://www.ups.com) Shipping Zones and Rates page for updates prior to tendering shipments.

¹ Surge fees may be implemented based on regular assessments of shipping volume, available capacity and other considerations. UPS reserves the right to impose one or more Surge Fees on parcels shipped during peak or high demand periods, at its sole discretion. Details regarding the application of Surge Fees are set forth at UPS.com Shipping Zone and Rates page. Surge Fee apply cumulatively if a parcel meets more than one of the specified criteria. Surge Fees apply in addition to any other applicable charges. No waiver, discount, or reduction of any kind shall apply to the Surge Fee unless UPS has agreed in writing to such waiver, discount, or reduction with specific reference to the Surge Fee.

- A Demand Surcharge will apply to all domestic and international shipments that require Additional Handling and Large Packages and will remain in place until further notice
- The existing Demand Surcharge rate for parcels that meet the specifications for Over Maximum Limits will increase.
- This fee is only applicable to customers billed in Italy.
- This fee is subject to Fuel Surcharge.
