2. DETERMINING THE RATE – SENDING SHIPMENTS

The rate for sending a UPS shipment is determined by its service level, destination zone, weight and any additional charges.

How to calculate your shipment rate:

- 1 Make sure that you are in the correct section. The sending rates in this section apply to any outbound international shipments.
- 2 Determine the billable weight.
- 3 Turn to the service option of your choice (UPS Express Plus, UPS Express, Express Saver, Expedited or Worldwide Express Freight).
- 4 Find your shipment type in the chart (UPS Express Envelopes, documents or packages). UPS offers separate rates for single package and multiple package shipments for the UPS Standard service.
- 5 Look up the rate that applies to the billable weight and zone for your shipment.
- 6 Note any additional costs, including charges for optional services.

To determine the zone number, see [Worldwide zones](#).

Billable weight – for small package shipments

Billable weight is the weight used to calculate the rate. For international services, the billable weight will be the greater of the dimensional weight as compared to the actual weight.

How To Calculate Billable Weight

Determine Actual Weight: Use any standard scale to determine the actual weight of your package. Increase any fraction to the next half kilogram.

Determine Dimensional Weight: Divide the cubic size of your package (length x width x height, rounding each measurement to the nearest whole centimeter) in centimeters by 5,000. Refer to the figure at the bottom of this page. Increase any fraction to the next half kilogram.

Determine Billable Weight: Compare the package's actual weight to its dimensional weight. The larger of the two weights is the billable weight and should be used to calculate the rate.

For multiple-package shipments, total the billable weight of all packages in the shipment.

All rates exclude any taxes, duties and surcharges that may be imposed pursuant to local regulations.

For correspondence and documents only. There is no limit on weight or number of pages you may enclose in a UPS Express Envelope.

Letter weight limit

Letter rates apply for international documents. There is a weight limit of 0.5kg for documents enclosed in an Express Envelope. Document or Non-Document rates will apply for envelopes weighing over 0.5kg.

Maximum weight

The maximum weight for an individual package is 70kg. If you need to ship single packages in excess of 70kg, please refer to our UPS Worldwide Express Freight service or call UPS on 1800-22-7171/1800-102-7171.

To determine the rate for a shipment weighing in total more than 70kg, 200kg (UPS Express Saver) or 100kg (UPS Expedited), add the total billable weight by the appropriate price shown.

The amount billed will be the result of the calculation, or the minimum rate shown, whichever is the greater.

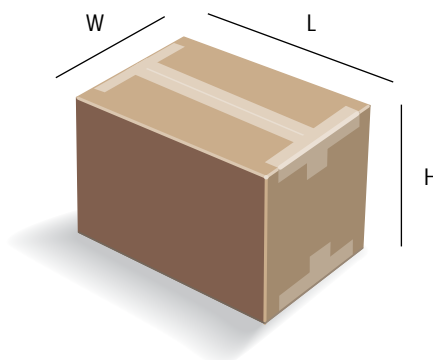

Billable Weight:

Actual or Dimensional?

Determining which weight to use in calculating your rate requires that you determine which rule applies.

Actual weight is the weight of the items on the pallet and the weight of the pallet rounded up to the next half kilogram.

Dimensional weight considers pallet density, which is the amount of space a pallet occupies in relation to its actual weight.

Billable weight is the weight used to calculate the rate. The billable weight will be the greater of the pallet's actual or dimensional weight. A minimal rate may apply.

Step 1

Determine the Actual Weight:

Actual weight is the weight of the items on the pallet and the weight of the pallet rounded up to the next half kilogram.

Step 2

Determine the Dimensional Weight*:

Calculate the cubic size by multiplying the length by the width and by the height (each rounded off to the nearest whole centimetre) of each pallet.

Divide the cubic size of the pallet by 5,000 to determine the dimensional weight in kilograms. Increase fractions of a weight to the next half kilogram.

Step 3

Determine the Billable Weight:

Compare the pallet's actual weight to the dimensional weight. The greater of the two is the billable weight and should be used to calculate the rate.

For multiple-pallet shipments, add up each pallet's billable weight to determine the shipment's billable weight.

Billable Weight Calculation

e.g.: A customer has a shipment of three pallets weighing 50 kg, 400 kg and 300 kg. All pallets are the same size with the following dimensions: 122 cm x 102 cm x 150 cm

1. Determine the Actual Weight

Actual Weight:

$$50 \text{ kg} + 400 \text{ kg} + 300 \text{ kg} = 750 \text{ kg}$$

2. Determine Dimensional Weight

Pallet Dimensional Weight:

$$(122 \text{ cm} \times 102 \text{ cm} \times 150 \text{ cm}) / 5000 = 373.5 \text{ kg}$$

Shipment Dimensional Weight:

$$373.5 \text{ kg} + 373.5 \text{ kg} + 373.5 \text{ kg} = 1,120.5 \text{ kg}$$

3. Determine Billable Weight

Shipment's Billable Weight:

$$373.5 \text{ kg} + 400 \text{ kg} + 373.5 \text{ kg} = 1,147 \text{ kg}$$

* For import shipments, use the origin country unit of measure and dimensional factor to calculate the dimensional weight.

3. DETERMINING THE RATE – RECEIVING SHIPMENTS

The rate for receiving a UPS shipment is determined by its service level, origin zone, weight and any additional charges.

How to calculate your shipment rate:

- 1 Make sure that you are in the correct section. The receiving rates in this section apply to any inbound international shipments.
- 2 Determine the billable weight.
- 3 Find the chart for the service level of your choice.
- 4 Find your shipment type in the chart (UPS Express Envelopes, documents or packages).
- 5 Look up the rate that applies to the billable weight and zone for your shipment.
- 6 Note any additional costs, including charges for optional services.

For inbound shipments, please ensure that the shipper records your UPS account number on the UPS shipping documents.

Billable weight – for small package shipments

Billable weight is the weight used to calculate the rate. For international services, the billable weight will be the greater of the dimensional weight as compared to the actual weight.

How To Calculate Billable Weight

Determine Actual Weight: Use any standard scale to determine the actual weight of your package. Increase any fraction to the next half kilogram.

Determine Dimensional Weight: Divide the cubic size of your package (length x width x height, rounding each measurement to the nearest whole centimetre) in centimetres by 5,000. Increase any fraction to the next half kilogram.

Determine Billable Weight: Compare the package's actual weight to its dimensional weight. The larger of the two weights is the billable weight and should be used to calculate the rate.

For multiple-package shipments, total the billable weight of all packages in the shipment.

All rates exclude any taxes, duties and surcharges that may be imposed pursuant to local regulations.

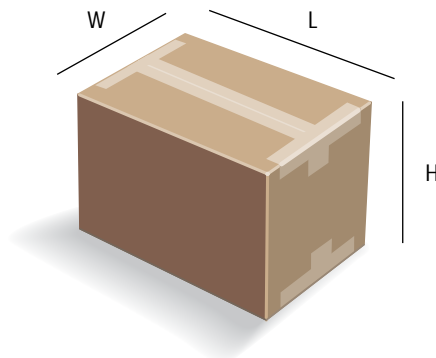

By using a UPS Access Point location, your customers can send or return items more easily. Shipments with UPS shipping labels already attached can be dropped off at a UPS Access Point location that is convenient to your customers. Your customers can also return unlabeled parcels if they present a mobile barcode (on their phone) to the UPS Access Point location attendant.

UPS Access Point mobile barcode shipping, where available, allows a person to drop off an unlabelled, sealed package at a UPS Access Point location by presenting their mobile barcode (on their phone) to the UPS Access Point location attendant.

Services with Additional Charges - Contractual

UPS Broker of Choice®

With UPS Broker of Choice, importers select their own customs broker for customs clearance of their UPS international shipments. This service is available for shipments using UPS Worldwide Express Plus, UPS Worldwide Express, UPS Worldwide Express Saver, UPS Worldwide Expedited and UPS Worldwide Express Freight.

This contractual, fee-based service ensures that the established relationship with a Customs Broker remains in place while the importer works with UPS to save time and increase efficiencies in shipping and customs processes. Using UPS Broker of Choice enables importers to reduce fees and errors incurred while using multiple customs clearance processes.

Importers have two options:

1. UPS Broker of Choice Onsite is for shipments that remain in UPS possession while the importer's customs broker completes customs clearance procedures prior to UPS completing delivery of the shipment. The fee for this is INR 3,575 per shipment.
2. UPS Broker of Choice Offsite is for shipments moved "in-bond" directly to a customs-controlled (bonded) warehouse (at the importer's direction) where the importer's customs broker completes the customs clearance procedures. The UPS transport is complete upon delivery of the shipment to the warehouse. The fee for this option is INR 5,700 per shipment.

UPS FTZ Facilitator®

With UPS FTZ Facilitator, importers and exporters have the ability to use UPS to transport international shipments "in-bond" to and from a global Free/Foreign Trade Zone (FTZ). This service is available for shipments using UPS Worldwide Express Plus®, UPS Worldwide Express®, UPS Worldwide Express Freight™, UPS Worldwide Express Saver™ and UPS Worldwide Expedited®.

This contractual, fee-based service allows the shipment of goods to move to or from an FTZ without using other transportation providers. Using UPS as a single source enables importers and exporters to increase visibility and tracking, and reduce the chance for errors and costs associated with utilising multiple transportation providers. Importers will choose UPS FTZ Facilitator to direct shipments to be delivered, in-bond, to a designated FTZ rather than being cleared through customs. The fee for this service is INR 4,618 per shipment.

Exporters will choose UPS FTZ Facilitator to ship goods in-bond from an FTZ to an international destination. The fee for this service is INR 4,618 per shipment.

Dangerous goods are articles or substances which are capable of posing a significant risk to health, safety or property if not handled and shipped in a proper manner.

There are various laws, regulations and rules governing the transportation of dangerous goods across international borders.

UPS offers a contractual service which ensures that your dangerous goods shipments are handled and shipped in accordance with international and domestic regulations via our global network. A surcharge of INR 3,520 per shipment or INR 322 per package applies, whichever is greater.
