



Surge Fee

September 15, 2025

In response to market conditions, the following updates will take effect **as of September 28, 2025, until and including January 17, 2026**:

- A **Surge Fee**¹ will apply to **international air shipments on selected lanes and services**. International Air services include Express, Express Saver, Express Plus, Expedited, and Worldwide Express Freight.
- A **Surge Fee** will apply to **domestic shipments** (domestic Standard, Express, Express Saver, Express Plus), and **international ground shipments** (transborder Standard, worldwide Standard), delivered to residential addresses. Commercial deliveries will not be subject to this fee.

This fee is subject to Fuel Surcharge and will apply based on the billable weight of the international shipments, and per package for domestic shipments.

Please note that Surge Fees are subject to change. Shippers should regularly check the UPS.com Shipping Zones and Rates page for updates prior to tendering shipments. Refer to the table below for applicable fees based on the origin and destination regions and/or countries or visit UPS.com Shipping Costs and Zones page for more information about fee changes.

¹ Surge fees may be implemented based on regular assessments of shipping volume, available capacity and other considerations. UPS reserves the right to impose one or more Surge Fees on parcels shipped during peak or high demand periods, at its sole discretion. Details regarding the application of Surge Fees are set forth at UPS.com Shipping Zone and Rates page. Surge Fee apply cumulatively if a parcel meets more than one of the specified criteria. Surge Fees apply in addition to any other applicable charges. No waiver, discount, or reduction of any kind shall apply to the Surge Fee unless UPS has agreed in writing to such waiver, discount, or reduction with specific reference to the Surge Fee.
